Agreement made this 26 day of July, 2007 by and between Local 2110, UAW and Rabinowitz, Boudin, Standard, Krinsky, & Lieberman, P.C.

The current Collective Bargaining Agreement between the parties is hereby extended for a period of one (1) year, retroactive to July 1, 2007, up to and including June 30, 2008 in all its terms and conditions except as specifically provided hereafter:

Effective July 1, 2007, all employees covered by the agreement shall receive an increase of forty-five dollars (\$45.00) per week, pro rated.

Effective July 1, 2007, the Sep I.R.A. annual contribution for qualified employees shall be increased to nine hundred dollars (\$900.00).
